The Developer will repair all roads, bridges, and culverts affected by construction of the Project as reasonably required to restore them to their preconstruction condition, as determined by the County Engineer in consultation with the local jurisdiction responsible for the roads, bridges, and culverts. In the event that the County Engineer deems any road, bridge, or culvert to be inadequate to support the construction or decommissioning of the energy facility, the road, bridge, or culvert shall be rebuilt or reinforced to the specifications established by the County Engineer prior to the construction or decommissioning of the facility. This Agreement constitutes the entire agreement between the parties and supersedes any prior oral or written agreements between the parties regarding the subject matter of this Agreement. The terms and provisions of this Agreement may only be amended by a written agreement duly executed by each of the parties.



The following departments gave an update on projects and daily functions of their staff; Building/Planning, Litter Control, Wellness, Dog Warden, Maintenance, EMA and IT.


