Absent such a written adjustment, the agreement automatically renews for a subsequent one-year term beginning on the day immediately following the end of the initial term unless either party gives the other thirty (30) day's prior written notice of its intent not to renew this Agreement. This Agreement cannot be automatically renewed more than five (5) times.
